TRAILWOOD SUB-ASSOCIATION PEDESTRIAN GATE CHANGES

The Trailwood sub-association is currently in the process of changing to a transponder and key fob entry system for its vehicle and pedestrian gates respectively. Once the distribution of transponders and key fobs is completed, the old keypad system will be disabled and this will change the route that some residents outside of Trailwood may take to school and for trail point access to Hick Canyon Trail. The Trailwood Board is aware that over the years, many of their neighbors and friends outside of Trailwood have become reliant on using this route for school. As a courtesy, the Trailwood Board wants to give people time to plan alternative routes accordingly.



COMMUNITY UPDATES

- The spring/summer pool use calendar will be posted on the pool area bulletin board beginning next month.
- ◆ The flower color at the Northwood Pointe monuments will be changed out this month. Additionally, the grass areas are being aerated and various plant material around the community is being cut back to encourage new growth to kick off spring.
- ◆ In preparation for the peak spring and summer pool usage, the following items will be completed this month: 1) the cleaning, degreasing and application of a protective coating on the pool chairs and lounges; 2) the cleaning and sealing of the shower tiles; 3) the acid washing and cleaning of the concrete restroom floors; and 4) the power washing of the sidewalk.
- ◆ AT&T is currently in the process of conducting some utility upgrades on existing easements on Northwood Pointe common area which in the future will offer residents expanded service options. Upon conclusion of the projects, AT&T will fully restore the common area.
- We are sensitive to the fact that at times temporary signs (i.e. school events, lost dog/cat, etc.) may be posted by residents around the neighborhoods. However, we ask that these notices and signs be promptly taken down after the event and/or within a reasonable amount of time. Thank you in advance for your cooperation.
- If you are planning any exterior improvements to your home (e.g. landscape, hardscape, remodel, painting) after our rainy months, now is the perfect time to start planning and preparing your architectural application for submission to Northwood Pointe. Please note that if you reside in Georgetown, Lanesend, Arborcrest I, or Northwood Villas, you will also have to submit for and obtain approval from your sub-association prior to submission of your application to Northwood Pointe. Upon completion of your approved improvements, a Notice of Completion with photos showing all the improvements installed and impacted areas is also required as part of the architectural review process. For your convenience, the Northwood Pointe architectural guidelines and application forms may be obtained on the Association's website at www.nwpointe.org.
- Remember to set your clocks one hour ahead before you go to bed on Saturday March 10th to prepare for Daylight Saving Time. While the daylight hours abound, please consider that more people will be out and about in our community taking advantage of the weather and longer daylight hours. Please keep a mindful eye out for pedestrians and our younger residents at play while driving through our community.


