
POOL REMINDERS— The Meadowood pool is heated year round at 82 degrees. Pool hours are from 6:00 am -10:00 pm daily.

LARGE UMBRELLA USAGE—The large shade umbrellas at the pool area may only be raised with a key and are purposely left closed if foul weather conditions (e.g. winds or rain) are anticipated, to avoid costly damage to the canvases, at the discretion of the janitorial service and the lifeguards on duty. Please do not attempt to force the umbrellas open as this will cost the Association to have them repaired.

ARCHITECTURAL GUIDELINES FOR NORTHWOOD POINTE

If you are considering completing exterior improvements to your home, please keep in mind that you must submit for architectural approval prior to commencing work. The review process allows 30 days for review of your submittal from the time of receipt of a completed application. Incomplete applications will be sent back for re-submittal and will not be considered. Due to the volume of submittals, Management cannot expedite the review of any applications; applications will be processed in the order in which the applications are received.
